CITY OF RAINBOW CITY-COUNCIL MEETING-FEBRUARY 10, 2020

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m., and upon roll call by City Clerk, Beth Lee, the following members answered present: Mayor Terry John Calhoun, Anita Bedwell, Bobby McCartney, Rodney Prickett, and Rick Hill. Larry Keenum-Absent. The same constituting a quorum of the City Council, the following business was transacted. The meeting was called to order by Mayor Calhoun. Invocation was given by Anita Bedwell. Mayor Calhoun led the Pledge of Allegiance to the flag.

- 1. Mayor Calhoun presented the minutes of regular Council meeting of January 27, 2020 for review, and asked if there were any corrections, additions, or deletions. - 4. Mayor Calhoun had a request to hire Bri Kelley as a Certified Court Magistrate effective Friday, February 14, 2020 at \$13.00/hr. with family coverage insurance. Rick Hill moved and Rodney Prickett seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.
- 5. Mayor Calhoun stated bids were opened in Pre-Council for the chemical regiment, fertilizer, and fire ant killer at the VLMSC and Recreation Center Little League Field. Five (5) bids were received as follows:

- 7. Mayor Calhoun presented the monthly reports from the Building, Library, Community Center, Recreation, Fire, Police, Court and Animal Control Depts.

- 9. Rodney Prickett presented an updated pay scale to be effective Friday, February 14, 2020. This pay scale is to be reviewed in four (4) years (2023). The Mayor will be will evaluate department heads, city clerk, and accounting positions in July/August of each year for budget purposes. Department heads (Revenue, Building, Court, Street, Recreation, Library, Police, Animal Control, and Fire Dept.) are to evaluate their employees. If a person is promoted during the fiscal year in a way that increases their salary, they would not qualify for a step raise that year. Rick Hill seconded the motion.
