**CITY OF RAINBOW CITY- COUNCIL MEETING-JANUARY 10, 2022**

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Jameson Jenkins. Mayor Taylor led the Pledge of Allegiance to the flag. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jameson Jenkins, Clark Hopper and Mayor Taylor. Jeff Prince-Absent. The same constituting a quorum of the City Council, the following business was transacted.

1. Mayor Taylor presented the minutes of regular Council meeting of December 28, 2021 and asked if there were any corrections, additions, or deletions. There being none, Randy Vice made a motion to approve the minutes as presented. Clark Hopper seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
2. Mayor Taylor asked for the records to show that the Economic Development Agreement for Team One Toyota was completed on November 30, 2021 and Hyundai of Gadsden was completed on December 29, 2021. (Agreement was signed on September 1, 2015).
3. Mayor Taylor stated sealed bids for approximately 3,300 sq. ft. addition to the Recycle Building located at 318 Kinzie Lane will be opened on Monday, January 24, 2022 at 4:30 p.m. Anita Bedwell made a motion to open sealed bids on Monday, January 24, 2022 at 4:30 p.m. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
4. Mayor Taylor presented the Fire Promotion Standards Testing for promotions for Lieutenant, Captain, and Assistant Fire Chief. Clark Hopper made a motion to accept the Fire Promotion Standards testing. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
5. Mayor Taylor had a request to post a Street Dept. position for ten (10) days to end on Friday, January 21, 2022. Anita Bedwell made a motion to approve the job posting. Randy Vice seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
6. Mayor Taylor presented Resolution No. 22-01 – Receiving the complete application of a Solid Waste Management Facility (MWT AL, LLC) to be located at 4618 Airport Road in Rainbow City. This facility will process pharmaceutical and medical waste under the supervision of ADEM using a proven non-incineration Pyrolysis process to protect human health and environment. Randy Vice made a motion to approve Resolution No. 22-01. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
7. Mayor Taylor presented Proclamation No. 22-01 – Human Trafficking Month (January) in Rainbow City and thanked our law enforcement/detectives for their combined efforts with other law enforcement agencies on this issue.
8. Mayor Taylor presented surplus items in the Recreation Dept. and Administration and asked for sealed bids to be opened on Monday, January 24, 2022 at 4:30 p.m. Anita Bedwell made a motion to approve the surplus list and for bids to be opened on January 24, 2022 at 4:30 p.m. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

9. Mayor Taylor presented the monthly departmental reports from Animal Control, Building, Community Center, Court, Fire, Library and Police Departments.

10. Mayor Taylor gave an update on the current street paving project.
