CITY OF RAINBOW CITY-COUNCIL MEETING-JUNE 22, 2020

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m., and upon roll call by City Clerk, Beth Lee, the following members answered present: Mayor Terry John Calhoun, Anita Bedwell, Bobby McCartney, Rodney Prickett, Larry Keenum and Rick Hill. The same constituting a quorum of the City Council, the following business was transacted. The meeting was called to order by Mayor Calhoun. Invocation was given by Rodney Prickett. Mayor Calhoun led the Pledge of Allegiance to the flag.

- Mayor Calhoun presented the minutes of regular Council meeting of June 8, 2020 for review, and asked if there were any corrections, additions, or deletions. There being none, Rick Hill made a motion to approve the minutes as presented. Larry Keenum seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.
- 2. Mayor Calhoun presented Resolution No. 20-07 Authorization to vacate a public road for petitioners Karl Adams, Denise Pfeifer, Joy Gail Adams, and Lou Anne Adams. The property is currently for sale and during this time, the petitioners discovered there was a public road on the property. Rodney Prickett moved to vacate the public road. - 5. Mayor Calhoun stated that the Economic Development Agreement with American Diversified Developments, Inc. (Rainbow Plaza) has been completed (June 2020).
- 6. Mayor Calhoun presented an Economic Development Agreement with Bobcat of Gadsden (opening in 2020). Anita Bedwell made a motion to authorize Mayor Calhoun to sign the Agreement. Rick Hill seconded the motion. Mayor Calhoun asked for a roll call as follows:

- 7. Mayor Calhoun stated the Notice of Election will be posted on Monday, July 6, 2020.
- 8. Mayor Calhoun stated that Milam Contracting hauled 429 loads of chert to the new Mega Sports Complex last week.
- 9. Rodney Prickett had a request from Andrew and Chance Bedwell to start/construct/maintain a "Little Free Library" at an approved location at Fire Station II and made this in form of a motion. Larry Keenum seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Anita Bedwell-abstained. Mayor Calhoun declared the motion carried.
- 10. Rick Hill read a statement that during the last Council meeting he neglected to bring up <u>vacation</u> accrual and usage for the Police Dept. 12-hour employees. Based on the way it has been accrued and taken, changing to hour for hour will cause the Police Dept. employees to lose time/days showing on the books. The 12-hour employees in the Police Dept. will build <u>vacation</u> time as follows:
 - 1 year 60 hours = 1 week
 - 2 years 120 hours = 2 weeks
 - 5 years 180 hours = 3 weeks
 - 10 years 240 hours = 4 weeks
 - 15 years 300 hours = 5 weeks

Vacation time will be taken at a minimum of one (1) hour increments. He also stated to give all 12-hour Police Dept. employees a one-time increase in vacation hours currently on the books of 3.6 hours per day effective Friday, June 26, 2020. All of the above was made in form of a motion by Rick Hill. Larry Keenum seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.

- 11. Rick Hill made a motion that the Director of Planning position was posted on June 12, 2020 to end on Friday June 26, 2020. Anita Bedwell seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.
- 12. Mayor Calhoun stated that two employees were exposed to COVID19 and had to be tested. He asked the Council to have the authority to pay these employees. Rodney Prickett made a motion to pay the employees. Rick Hill seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.
- 13. Anita Bedwell made a motion to give the Mayor authorization to sign a contract with InSite Engineering, LLC to do preliminary engineering extending sewer from VLMSC to Pleasant Valley Road for a cost of \$21,800.00. Rodney Prickett seconded the motion. Mayor Calhoun asked for a roll call as follows:
