CITY OF RAINBOW CITY-COUNCIL MEETING-OCTOBER 25, 2021

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Jeff Prince. Mayor Taylor led the Pledge of Allegiance to the flag. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Jameson Jenkins and Mayor Taylor. Clark Hopper-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of regular Council meeting of October 11, 2021 and asked if there were any corrections, additions, or deletions. There being none, Jeff Prince made a motion to approve the minutes as presented. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

The estimated cost is \$17,000.00. Randy Vice made a motion to approve the agreement. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 5. Mayor Taylor presented a recommendation to authorize the City Clerk to advertise for bids for the RBC-2021-01 additional lane on Steele Station Road from Natco Dr. to SR-77. This will be for Grade, Drain, Base, Pave, and Signal along Steele Station Road. Randy Vice made a motion to approve the recommendation. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 6. Mayor Taylor presented a donation request from the Community Thanksgiving Celebration to be held on Thursday, November 25, 2021 at The Venue from 10:00 a.m.
 2:00 p.m. Jeff Prince made a motion to donate \$1,500.00. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 7. Mayor Taylor presented a donation request from Liberty Learning. This program is presented to the elementary schools for civics education. Jameson Jenkins made a motion to donate \$2,000.00. - 8. Mayor Taylor presented request to promote Jarrod Pell to Sergeant in the Detective Division effective Friday, October 29, 2021. Randy Vice made a motion to accept the promotion request. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 9. Mayor Taylor presented a surplus list from Administration. Jeff Prince made a motion to accept sealed bids to be opened on Monday, November 8, 2021 at 4:30 p.m. These

Mayor Taylor opened the floor and asked if anyone was present to speak for or against this proposed change. A public notice was posted on October 12, 2021 for this Public Hearing. No one spoke for or against this. Anita Bedwell made a motion to approve the swapping of equipment. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

Public Comments Vashtie Gilliland 527 LaSalle Street spoke regarding Edge Motors and the cars parked along Montrose Avenue (provided pictures), yards on Montrose Avenue that needed to be mowed, and a house trailer. Joyce Elliott 525 LaSalle Street spoke about her ditch needing opened up as the water was backing up on her property. Mayor Taylor stated the Street Dept. head was present and would discuss with them after the meeting and that the new Nuisance Abatement Officer would be contacted about the yards, trailer, and cars.
